### PERMISSION, RELEASE OF LIABILITY AND MEDICAL RELEASE

I, hereby expressly consent to my participation in the above named special event. I acknowledge that such participation includes but is not limited to, travel (public or private), preparation for competition, competition skiing, snowboarding, and snow-play at Mad River Mountain and other recreational facilities.

I understand that the sport of skiing/snowboarding, and other snow-play activities, involves inherent other risks of INJURY or DEATH. I voluntarily agree to expressly assume all such risks which may result from skiing/snowboarding, or any other snow-play activity at Mad River Mountain, or in any way related to my participation in the above named special event, including but not limited to snow and various conditions, ice, sheer drop-offs, bare ground, roots, stumps, trees, lift towers, ruts, bumps, snowmaking equipment, grooming vehicles, snowmobiles, debris, and conditions of any gladdened wood areas, collisions with other skiers, design and conditions of natural and man-made terrain features, power poles and a multitude of other objects that are inherent to all forms of alpine activities.

In consideration of the right to participate in the above named event, I hereby release from any legal liability Mad River Mountain, or any officer, affiliated organization, agent or employee for injury or death caused by or resulting from my participation in the sport of skiing/snowboarding, or any other snow-play activity or use of the facilities (including chair lifts) of Mad River Mountain or in any way connected to my participation in the above named special event, whether such injury or death was caused by the alleged negligence of Mad River Mountain, another skier/snowboarder, or any other person or cause.

I further agree to defend and indemnify Mad River Mountain for loss or damage, including any that result from claims or lawsuits for personal injury, death, or personal property damage, related in any way to my participation in the above named special event or use of Mad River Mountain facilities.

I authorize any person connected with this event or with Mad River Mountain to administer first aid to me as they deem necessary. I authorize medical and/or surgical care and transportation to a medical facility or hospital for treatment necessary for my well being at my expense.
